Delta Gamma Revises Alcohol Policy

Much-Needed House Improvement Projects Slated for Summer

Greetings from Dodd Hall!

••• Chapter Changes Alcohol Policy

At the Dodd Hall meeting on April 24, the undergraduate chapter recommended changing our University-recognized alcohol status from wet to dry/damp. The trustees agreed that this change, which would go into effect for the 2011-12 school year, is for the best. The deadline for policy changes for the, 2010-11 academic year, was last fall, so the chapter's status will remain technically wet and this will be a transitional year. The Pikes are the last wet chapter following the recent suspension of Sigma Chi.

A little background is needed. Two years ago Miami University instituted its Second Year initiative, in which all sophomores are required to live in university housing (dormitories).

Dry/damp fraternities were issued exemptions for their sophomores if they met higher academic and alcohol requirements. Our chapter believed it could adjust by filling the house with juniors and seniors. Historically 60-65% of the men living in Miami's fraternity houses are sophomores. This year, the chapter found it increasingly difficult to fill the house, but also found that out-of-house sophomores were much less engaged or active in the chapter. Recruitment was also tough. We netted 17 new members in our main winter recruitment period and have eight spring pledges. Ideally, we would like to recruit 30-40 new pledges per year.

The new damp status requires no alcohol in the common areas of the house, except

for approved alumni events. Legal-age members are allowed alcohol in their rooms, and sophomores must have a minimum G.P.A. of 2.5 to live in the house, which is also the minimum to pledge any fraternity. Our chapter has tried to recruit freshmen with a G.P.A. of at least 2.75-3.0. Damp chapters must also have a live-in resident advisor. These will be drastic changes in many ways, but they are for the best and will benefit the Chapter in the long run.

••• House Improvements

After spending some of our "future" money to fund a number of improvements last summer, our winter projects and planned summer projects are modest. The old TV room on the second floor was converted to a three-man residential room; the cost was approximately \$10,000 and will increase our maximum capacity to 44 men. Summer plans include additional security lights in the rear of the house, green room updates, and several lower floor doors and frames. Additionally, all common areas

Members Grateful for House Improvements and Take Steps to Protect Investment

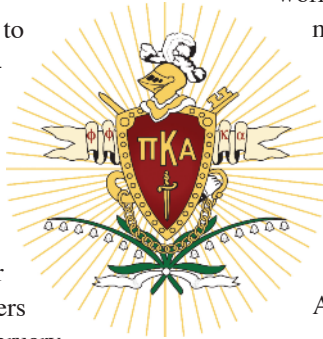
